Call to Order:

The meeting was called to order by Chairman N. Adams at 6:30 p.m. Assigned Secretary, Niki Butler, called the roll. All seven Board members were present.

Welcome visitors: Chairman N. Adams welcomed the Board, staff members and 30 guests attending the meeting.

Open agenda for proposed new items:

Chairman N. Adams suggested to have Public Comments moved to beginning of the agenda to accommodate citizens wishing to speak. Visitors from the sign-in sheet indicating a desire to speak were called up one at a time. N. Adams addressed the public and provided rules of procedure, including a three-minute time limit per speaker.

Motion by W. Matthews to move Public Comments to the beginning of the agenda. Seconded by R. Danielson. Vote 7-0 in favor.

N. Adams spoke about Constitutional Rights of renters and the opinion of the District Attorney's office. He also stated that it is important that Recreation District #1 does not use public funds for preventable litigation.

Approval of minutes (attachments):

Motion by R. Danielson to accept the board meeting minutes from the regular monthly meeting on August 16, 2023 and the special board meeting on September 7, 2023 as presented. Seconded by W. Matthews. Vote 7-0 in favor.

RCL Architecture Presentation

Motion by W. Matthews to move the presentation by RCL Architecture, LLC up in the agenda. Seconded by R. Danielson. Vote 7-0 in favor.

Paul Dimitrios shared information about the Event Stage project and the three bids received in September were all considerably over budget. Following a meeting with J. Dexter and L. Scott on September 6th, P. Dimitrios revised the design and materials to bring costs down to \$765,000. He was doubtful that the Event Stage could be built for \$650,000 and asked to increase the budget as nearly all bids are received over budget lately. N. Adams inquired about reducing the size of the stage. B. Matthews inquired about the timeline moving forward. P. Dimitrios would like to complete revisions and return the plans to the structural engineer (approximately two weeks), then have an estimator look at the construction drawings (approximately one month). P. Dimitrios will then present revised package with estimates to the board for approval on new design and budget. Overall, he expects this to take between one to two months.

Motion by W. Matthews to reject all bids received for the Event Stage. Seconded by S. Lemoine. Vote 7-0 in favor.

Financials:

N. Adams presented a brief explanation of the financial report provided by S. Goodwill. N. Adams drew attention to the Castine Center revenues, the field revenues, and the insurance expenses. N. Adams stated that we should have some surplus at end of year to hopefully be able to do more Capital projects.

Motion by N. Adams to approve the financials as presented. Seconded by S. Lemoine. Vote 7-0 in favor.
