Call to Order:

The meeting was called to order by Chairman N. Adams at 6:35 PM, in the Castine Center Conference Rooms, 63350 Pelican Drive, Mandeville, LA 70448.

Roll Call:

Assigned Secretary, M. Dupre, called the roll. Five of the seven Board Members were present. Majure Savell has resigned as a Vice Chairman with effective date of September 21, 2023. deShea Richardson, Commissioner was absent

Old Business:

Announcement of Public Meeting to consider adopting resolution for renewal or replacement ad valorem taxes

N. Adams, introduced Grant Schlueter, of Foley & Judell, LLP, to discuss an option for bond issuance in April (2024).

Mr. Schlueter discussed with Board Members and staff the status of the District's two (2) property tax millages, Special and Special 2, with regard to renewal dates and the options available for the Board to consider. If the District's wishes to generate revenue for additional capital improvements, the millages would need to be renewed, as they have limited duration remaining. Mr. Schlueter recommended a course of action to put an in-lieu-of tax proposal on the ballot (public vote) for 6.05 mills; which is the aggregate of the two (2) millages and cancelling out the current Special tax millages. Following, 20-year limited bond issuance of \$6.5MM could occur. The taxes would be recognized in the 2024 tax roll with available tax revenue in 2025. The two current bond issuances would need to be paid off, approximately \$2.2MM, leaving approximately \$4MM available for capital outlay.

N. Adams: an advantage to getting \$4MM, would allow the current tax payers the benefit of projects now. With the current capitol program (outlay) of \$7MM, plus interest earned, plus any unused capital project funding, we would have available a \$12MM - \$15MM available for capitol. Which is significant if we could build the planetarium, or down the line with the (Northlake) Nature Center. N. Adams furthered explanation of April election versus Fall election (opinion).

Discussion continued between the Board Members, staff and Mr. Schlueter regarding the matter.

In order to place the option for vote on the election ballot for April 27, 2024, several steps must be taken. One is to read aloud a meeting announcement during the Board meeting.

The following was read by Mr. Schlueter:

Announcement of Public Meeting

Notice is hereby given that at its meeting to be held on Wednesday, November 15, 2023 at 6:30 p.m. at its regular meeting place, the Pelican Park/Castine Center Conference Room, 63350 Pelican Drive, Mandeville, Louisiana, the Board of Commissioners of Recreation District No. 1 of the Parish of St. Tammany, State of Louisiana, plans to consider adopting a resolution ordering and calling an election to be held in Recreation District No. 1 of the Parish of St. Tammany, State of Louisiana to authorize the renewal or replacement of ad valorem taxes.

The announcement will also be published on October 25, 2023 in the Legal Section of the District's Official Journal of Record, the St. Tammany Farmer. As well as distributed to the St. Tammany Parish Council, and the District's State of LA representatives.

A vote to approve is not necessary at this time. At the November 15, 2023 Board of Commissioners' Meeting, a Board Resolution will be required, approving the actions to place the item on the April 27, 2024 election ballot.

Event Stage authorization for bids and budget allocation

N. Adams, introduced Richard Lambert, RCL Architecture, LLC.

RCL Architecture, L.L.C, presented an update to the Board and staff regarding the Event Stage project with respect to re-design and costs for build. The cost is being targeted at the original budget of \$650,000. Alternatives/alternates will be included in the bid package. The project is ready to go out for public bidding.

Discussion: 95% of the design remain, major changes from the previous design include reduction in size, and roof materials.

Dexter, will follow. Including self-insuring for commercial property.

N. Adams reviewed the credit card statement for September 2023, in the absence of a Vice Chairman. Bonus points on the statement can be deducted from the statement or cash redemption. N. Adams approved the credit card statement.

Insurance renewal

J. Dexter presented the options being proposed by HMIA, Wind and Hail coverage for the Castine Center/Office, with a renewal date of 10/27/2023. The policy was \$95k (2023) with an increase to \$139k (2024). Recommendation is to not renew the December 2023 policy and to move the \$150+/- surplus of the 2023 budgeted Insurance line item to a newly created Insurance Fund to allow for contingencies related to property damages.

- Master Plan presented by L. Scott (attachment)
 - L. Scott provided progress reports on the following projects:
 - Event Stage redesign will be provided by RCL Architecture, LLC
 - The Survey (public input) for the skatepark/pump track has been provided to the Board Members. The second community engagement will be held on Wednesday, October 25th, 6:30 – 8:30 PM in the Castine Center, where Newline Skateparks will provide attendees with the conceptual drawings of the project. All are welcome to attend.
 - L. Scott met with Northlake Nature Center Board Member, Larry Burch, to discussion included the development of a maintenance plan for the property.
 - The currently proposed location of the pickleball courts may need to be revisited due to current infrastructure. Quality Courts will conduct a site-visit to discuss options for alternative locations.
 - A draft copy of the water well hydraulic study, being conducted by Neel-Schaffer, LLC, should be available in approximately 12 weeks for Board review. Once the Board approves the options, the project could potentially be completed by Summer of 2024. She further detailed the projects scope of work.
 - The Geographic Information System (GIS) project is moving forward. Plans include scanning the District's physical blue prints allowing for digital access.
 - Wildlife and Fisheries (Louisiana Department of Wildlife and Fisheries) stocked the Groves Pond with 200 channel catfish last week. Future plans are to add blue gill and white mouth bass. Discussion: open to the public fishing vs District sponsored fishing events. Staff will consult with W&F to develop options. The next newsletter will include information of the project.
